

# HOUSING AND DINING CONTRACT ACADEMIC YEAR 2025-2026

This contract is made and entered into by and between The Curators of the University of Missouri on behalf of the University of Missouri-Kansas City, hereinafter referred to as "UMKC", and the person identified on the contract, hereinafter referred to as the "Student". If the Student is under the age of 18, a parent or legal guardian must agree to the terms of this contract by completing the minor consent process. This contract is for the entire academic year indicated above, hereinafter the "Academic Year", consisting of fall and spring semesters or, if entered into after the beginning of the Academic Year, for the remainder of the Academic Year. The fees for the housing and dining services are determined annually and adopted by the University's Board of Curators prior to the beginning of the Academic Year. The University reserves the right to modify by increasing or decreasing the fees charged for attendance and other services at the University, including, but not limited to, educational fees, at any time when, in the discretion of the governing board, the same is in the best interest of the University, provided that no increases can or will be effective unless approved by the Board of Curators not less than thirty (30) days prior to the beginning of the academic term (semester, etc.) to which the fees are applicable with all modification of fees to be effective irrespective as to whether fees have or have not been paid by or on behalf of a student prior to the effective date of the modification.

With this contract, UMKC offers to the Student accommodations for the above referenced Academic Year. Accommodations are University owned or operated facilities including housing acquired by the University to house Students exceeding capacity. When the contract is received by UMKC, a legally binding contract between the Student and UMKC is established. The Student will be asked to indicate preferences for their housing assignment. The University makes no guarantee that it will be able to assign the Student to any particular location or type of accommodation. Student may cancel this contract only for conditions that meet those listed in Cancellation and Termination section. It is understood that the Student must be enrolled full time (12 credit hours undergraduate, 9 hours graduate) at UMKC during the term of this contract. Students assigned to residence halls (Johnson Hall or Oak Street Hall) are required to purchase a UMKC Dining Plan from options under the category of "Resident Dining Plans." Students assigned to apartments (Hospital Hill Apartments or Rockhill Apartments) are not required to have a UMKC Resident Dining Plan, however, they do have the option to purchase a UMKC Resident Dining Plan from options under either of the categories of "Commuter Meal Plans" or "Resident Dining Plans." Rooms may be occupied according to the Guide to Group Living. Rooms may be occupied during the term of this contract. Students must register in advance to remain during academic break periods. Residential services may operate at a reduced schedule during academic break periods. Termination of this contract for any reason whatsoever will not relieve Student from liability for payment of all sums, including any charges for damages.

The Student and UMKC hereby agree to all the terms, conditions and provisions set out as part of this contract and in other documents which are incorporated by reference into this contract. These documents include the Contract, Guide to Group Living (GGL), UMKC Parking Regulations, Residential Life and dining publications, University of Missouri Collected Rules and Regulations which are now, or are hereinafter, in effect.

This contract is not a lease, UMKC is not a landlord, the student is not a tenant, and nothing herein is intended to create such a relationship or is otherwise subject to any landlord-tenant laws or requirements. This is a license to occupy university housing as part of an academic community in connection with the educational experience and in furtherance of UMKC's mission.

# University Agreement: \*\*

UMKC agrees to furnish the Student with housing and dining services when a meal plan is selected. These services are provided under the terms herein stated and as described in the Residential Life and dining publications and websites and the Guide to Group Living.

Alterations of this contract are not recognized by UMKC. Failure to honor the Student's assignment preferences will not void this contract. UMKC will not discriminate in housing assignments on the basis of race, color, national origin, ancestry, religion, sex, pregnancy, sexual orientation, gender identity, gender expression, age, disability, protected veteran status, or any other status protected by applicable state or federal law. UMKC reserves the right to assign roommates and/or to consolidate vacancies by requiring students to move from one accommodation to another when deemed appropriate by UMKC.

UMKC requires that each Student pay the UMKC Residential Life educational and social fee of \$30 per Academic Year.

Contracts for University housing are subject to a check against the Missouri State Highway Patrol's Missouri Sex Offender Registry. Housing assignments shall be considered tentative and subject to modification or cancellation pending completion of this registry check. Further, Students may be subject to interim suspension or emergency removal from university housing under student conduct and equity policies adopted by the University.

Students assigned to Johnson or Oak Street Hall are required to select a resident dining plan. If a student does not select a resident dining plan by the required date, they will be assigned and required to pay for the lowest priced resident dining plan. Students assigned to Hospital Hill Apartments or Rockhill Apartments are not required to select a resident dining plan. Students may change their dining plan for the semester until Friday of the first week of class.

UMKC does not purchase property insurance covering any loss of, or damage to, the Student's personal property, and UMKC assumes no responsibility for the payment of any such loss. Students are encouraged to obtain individual personal property insurance.

UMKC reserves the right and privilege to: (a) refuse any contract; (b) change the room assignment and require the Student to move to different accommodations when UMKC deems it expedient, in which event the Student's account will be credited or charged with any difference in charges; (c) take over and use the room in event of public emergency; (d) in the event that the accommodations assigned to the Student are destroyed or otherwise made unavailable and UMKC does not furnish other accommodations, the contract shall terminate and all rights and liabilities of the parties hereto shall cease and the right of UMKC and the Student to payments previously made by the Student shall be prorated on the basis of the period for which accommodations were made available to the Student; (e) change the rate for room and meals during the academic year if changes in economic conditions make it necessary; (f) inspect the room at any reasonable time and, if there is reason to believe that the Student has violated UMKC regulations, to inspect the Student's possessions.

Students whom the University has determined constitute a risk of disruption or harm to the health, safety, or welfare to the Student or members of the University community, may be subject to housing assignment relocation, interim housing suspension or immediate cancellation of the housing assignment.

### **Student Agreement:**

The Student agrees to honor this contract **FOR THE ENTIRE CONTRACT PERIOD** and make payment of all charges regularly fixed for the accommodations assigned. If the Student is under 18 years of age, the Parent or Guardian agrees to make payment of all charges. The Student agrees that failure to satisfy the financial obligations accrued under this contract may result in denial of issuance of grade transcripts and/or permission to re-enroll, pursuant to UMKC rules and regulations governing the imposition of these sanctions.

The Student agrees to reimburse UMKC for all damage to the structure in which the Student is housed and all damage to, or loss of, any UMKC fixtures, furnishings, or personal property furnished under this contract caused by the acts or negligence of the Student. Student agrees that they may be required to reimburse UMKC for damage to common areas of the facility when individuals causing the damage cannot be identified.

The Student agrees to assume and bear the risk of loss with regard to all personal property which is kept or maintained in UMKC housing.

The Student agrees to refrain from making any modifications, whether structural, electrical, or plumbing to facilities, nor to attempt any construction or remodeling, no matter how minor, without advance written approval from the UMKC Residential Life.

The Student agrees to comply with UMKC Guide to Group Living and UMKC policies, which are now, or are hereafter, in effect, which Guide to Group Living is specifically made a part of this contract by reference.

The Student agrees that this contract is **FOR THE ENTIRE ACADEMIC YEAR** or, if the contract is for accommodations after the beginning of the Academic Year, for that part of the Academic Year remaining after the effective date of assignment to accommodations. The Student agrees this contract cannot be canceled either before or during the Academic Year except under the terms set forth in the Cancellation and Termination sections of this contract.

The Student agrees that failure to occupy assigned accommodations on or before the first day of classes of the period covered by this contract without having given UMKC Residential Life written notice of delayed arrival may result in the accommodations being assigned to another Student; but delayed arrival does not relieve the Student of the responsibility to accept other available accommodations. The Student agrees that assigned accommodations cannot be reassigned by the Student to another individual.

The Student agrees to notify UMKC Residential Life, in writing, within five (5) days after occurrence, of any alleged violation by UMKC of any of its obligations arising under this contract or otherwise. Failure of resident to give such notification in writing, within the time prescribed shall constitute a total and complete waiver of said alleged violation and shall not be asserted by resident as any grounds for nonperformance of resident's obligations under this contract.

#### **Community Living Acknowledgement**

Residential Life at UMKC is a community of scholars living and engaging with fellow students, staff, and faculty from a broad range of backgrounds and experiences. This is an opportunity to learn and to develop skills necessary for future careers and citizenship, this development occurs as a result of the challenges and support experienced as a member of the Residential Life community. Community living is an interdependent experience where residents are expected to engage with other community members to constructively contribute. Residents will interact with roommates, suitemates, apartment mates, and neighbors who may have different ways of living including noise levels, communication styles, study patterns, cleanliness and other differences. There are also characteristics of the physical

environment, such as the availability of each room type, the structure of community space, and location of facilities that not every student may get their highest preference. As a member of the community, residents are expected to participate in communication with other members to resolve concerns and to communicate needs to UMKC Residential Life.

## Crisis Acknowledgement:

The Student recognizes that UMKC cannot control nor prevent emergencies, pandemics and other acts of God. The University cannot guarantee that Student will not experience an emergency, pandemic or act of God.

Student may become exposed to or infected with an infectious disease while living in facilities owned or operated by Residential Life. Further, living in UMKC Residential Life could elevate the risk of contracting any contagious illness simply due to the dense populations in the residence halls and apartments.

Student acknowledges the contagious nature of infectious diseases and the risk of possible exposure by living in a Residential Life owned or operated facility as well as entering dining facilities. Student understands that the risk of becoming exposed to or infected by an infectious disease in UMKC Residential Life may be affected by the conduct of Student and others.

Student understands that they have a responsibility to care for themselves and others in their community. They must adhere to the University guidelines on how best to prevent the spread of infectious diseases. Student understands in order to move into a housing assignment, they must arrive with required preventative and safety materials as directed by Residential Life, UMKC and other entities.

Student understands should they exhibit any signs or symptoms of a highly infectious diseases, as enumerated by the Centers for Disease Control and Prevention (CDC), or they have been in close contact with someone who has a highly infectious diseases it is the responsibility of the Student to immediately follow current CDC guidelines.

Student understands prior to official opening day or at any point while living in UMKC Residential Life, Student may be instructed to perform specific preventative actions to reduce communal disease transmission. Should Student need to self-isolate or self-quarantine prior to official opening day or while living in UMKC Residential Life, they will notify Residential Life.

Student understands and affirms that, in the event of an emergency, Student will call 911, and that Student should notify the operator that they have, or think they might have, an infectious disease. Student understands that they may be required to move to another room, hall or other location in the event of required self-quarantine or isolation. Credit or refund will not be made for primary assignment while student is in alternative location for quarantine or isolation. Student understands amenities and services are limited at these accommodations. Isolation or quarantine accommodations may be billed to the Student's account.

Student understands that UMKC Residential Life reserves the right to alter policies and procedures to respond and address emergencies, pandemic and crises that are in the best interest of UMKC and the Student. This may include, but is not limited to, visitation hours, guests or restricting access and use of spaces such as lounges, kitchens, and other communal spaces.

Student understands that Residential Life may find it necessary to take specific actions to protect the public health of residents which may include communicable diseases.

Student understands Residential Life will be housing students with roommates/suitemates/apartment

mates and that all rooms/suites/apartments have shared space of some kind (e.g., bathroom, kitchen, living room).

Student understands that, in conjunction with assigned roommate/suitemates/apartment mates, Student may be required to complete a shared living agreement to establish living parameters and understandings regarding preventing, mitigating, and managing infectious diseases pandemic within the living space(s).

Student understands that, should an emergency situation occur and the University requires full or partial closure of UMKC Residential Life, the University may terminate and suspend the housing and dining contract for impacted students and students must vacate the facilities and remove their belongings. Residential Life and campus dining in conjunction with the University will communicate appropriate billing impacts including adjustments. However, if there is an emergency event and the University does not require UMKC Residential Life to enact full or partial closure or require students to vacate, the students may still do so, but the housing & dining contract will remain in full effect and the students will not be entitled to a housing and dining adjustment (refund/credit) even if they voluntarily choose to vacate.

#### Cancellation and Termination:

1. Request to cancel contract by Student Prior to Check-in: if the contract is received by UMKC and the student later decides not to live in Residential Life, the Student must submit a request to cancel using the RooRez portal. Requests to cancel submitted prior to the student checking into Residential Life will be granted and the student will incur cancellation fees and charges according to this schedule:

### A. Returning Residents:

- Request to cancel received by March 1, 2025 will be approved and have no cancellation fee.
- 2) Request to cancel received March 2, 2025 through June 1, 2025 will be approved and will have a cancellation fee of \$100.

## B. New Residents:

- 1) Request to cancel received by May 1, 2025 will be approved and have no cancellation fee.
- 2) Request to cancellations received May 2, 2025 through June 1, 2025 will be approved and have a cancellation fee of \$100.

#### C. All Residents:

- 1) Request to cancel received June 2, 2025 through July 1, 2025 will be approved and have a cancellation fee of \$200.
- Request to cancel received July 2, 2025 or after AND prior to the first day of Residential Life check-in AND prior to the Student's check-in will be approved and will have a cancellation fee of \$300.
- 3) Request to cancel received the first day of Residential Life check-in through September 1, 2025 AND prior to the Student's check-in will be approved. There will be a cancellation fee of \$300 plus the nightly rate for their room type for all nights from the first day of check-in until the contract is cancelled.
- 2. Request to cancel contract by Student After Check-in: if the contract is received by UMKC Residential Life and the student checks-in, cancellation is permitted only under specified circumstances. A request to cancel the contract and documentation supporting the reason for the request must be submitted in the RooRez Portal. Requests will be reviewed

and approved or denied based on the submitted documentation.

### A. Reasons for cancellation requests after check-in:

- 1) No longer a UMKC student includes graduating, military deployment, transferring, or withdrawing.
- 2) Participating in a UMKC-sponsored program which requires living away from Kansas City includes internship, study abroad, or student teaching.
- 3) Exchange students at the conclusion of their program.
- Change in family status that requires housing type not available at UMKC marriage, birth or adoption of a child.
- Medical or mental health issue that cannot be effectively treated while the student resides in Residential Life.
- Substantial financial hardship beyond the student's control that occurred after the student moved into Residential Life.

# B. Fees for approved cancellation after check-in:

- 1) Request to cancel and documentation received through September 1, 2025 and checking out within 24 hours of the approval of their cancellation will have a cancellation fee of \$300 and will pay the nightly rate for their room type until their check-out.
- Request to cancel and documentation received September 2, 2025 through September 15, 2025 and checking out within 24 hours of the approval of their cancellation will receive a 60% credit of the housing charge for the semester.
- Request to cancel and documentation received September 16, 2025 through September 30, 2025 and checking out within 24 hours of the approval of their cancellation will receive a 40% credit of the housing charge for the semester.
- 4) Request to cancel and documentation received October 1, 2025 through October 15, 2025 and checking out within 24 hours of the approval of their cancellation will receive a 20% credit of the housing charge for the semester.
- Request to cancel and documentation received after October 15, 2025 will receive no credit of the housing charge for the semester.
- Requests to cancel approved to be effective at the end of Fall Semester will pay a cancellation fee of \$300. This cancellation fee will be waived for approvals due to graduation, military deployment, participation in UMKC sponsored programs, exchange students at the conclusion of their program, or financial hardship.
- Request to cancel and documentation received through February 1, 2026 and checking out within 24 hours of the approval of their cancellation will have a cancellation fee of \$300 plus the nightly rate for their room type until their check-out.
- Request to cancel and documentation received February 2, 2026 through February 15, 2026 and checking out within 24 hours of the approval of their cancellation will receive a 60% credit of the housing charge for the semester.

- Perceived February 16, 2026 through February 30, 2026 and checking out within 24 hours of the approval of their cancellation will receive a 40% credit of the housing charge for the semester.
- Request to cancel and documentation received March 1, 2026 through March 15, 2026 and checking out within 24 hours of the approval of their cancellation will receive a 20% credit of the housing charge for the semester.
- 11) Request to cancel and documentation received after March 15, 2026 will receive no credit of the housing charge for the semester.
- The cancellation fee will be waived for approvals due to graduation, military deployment, participation in UMKC sponsored programs, exchange students at the conclusion of their program, or financial hardship.
- Dining charges for Resident Plans will be prorated based on date of check out of Residential Life.
- C. Contract Termination by UMKC due to Breach by Student: A Student's withdrawal, suspension, dismissal, or expulsion from Residential Life or UMKC by UMKC for any reason, including, but not limited to violation of the Guide to Group Living, the University of Missouri Collected Rules and Regulations, or other conduct on the part of the Student deemed to require the removal of the Student from Residential Life housing or UMKC for the best interest of the other residents, shall constitute a breach of the Residential Life Housing and Dining Contract by the student and shall be grounds for the termination of the contract at the election of UMKC. In case of such a termination, UMKC will deliver a written notice of termination to the Student by email, mail, personal delivery, or by leaving the notice in the Student's room, stating the hour and date the termination takes effect. Failure to vacate by the termination effective date and time may result in an eviction process and associated charges. The student will have financial obligations as outlined in 2.B. of Cancellation and Termination. The resident dining plan will be prorated based on the later of the termination effective date check-out date. A commuter meal plan will be retained by the Student if they remain enrolled at UMKC. If the Student is no longer enrolled the commuter meal plan will be prorated based on usage. If the contract is breached due to the Student's withdrawal, suspension, dismissal, or expulsion from UMKC and the Student re-enrolls during the period covered by the contract, UMKC may elect to reinstate the contract as of the date of re-enrollment.
